These Terms and Conditions of Sale (the "Terms") apply to all quotations and sales by ASC Profiles LLC (including its AEP Span, ASC Building Products and ASC Deck Divisions, "ASC") of products, materials, services, components, accessories, and panels (collectively, "Products"). No terms or conditions other than those stated in these Terms, and no agreement or understanding, oral or written, purporting to modify these Terms, whether contained in a purchaser's purchase forms or elsewhere, will be binding on ASC unless signed by an authorized executive manager of ASC. The purchaser ("Purchaser") consents to these Terms for all Products.

- 1. Cancellation. Purchaser will not have the right to cancel an order after it has been accepted by ASC without paying a cancellation charge.
2. Price. Prices for Products will be based on the price applicable at the time of the order and are subject to change without notice...
3. Payment. (a) Subject to ASC Credit Department approval... (b) If, in the sole judgment of ASC, it appears that Purchaser may not be able to make payment when due...
4. Shipment. (a) Unless otherwise specified in writing, ASC has no obligation to deliver Products beyond ASC's facility...
5. Returns. No Products may be returned unless ASC authorizes the return.
6. Risk of Loss and Title. Title to Products, together with the replacement and additions to the Products, remains in ASC until all amounts due are fully paid...
7. Warranty. ASC warrants that Products delivered shall be free from defects in material and workmanship for a period of 90 days...
